
Dear Esteemed Members.

Α. **Significant Accounting Policies:**

1. Basis for preparation of Financial Statements:

The financial statements are prepared under the historical cost convention, the applicable Accounting Standards, the relevant provisions of the Cost and Works Accountants Act, 1956, as amended and are on accrual basis unless otherwise stated.

1. Registration Fee:

Registration Fee received from students is recognized as revenue income as and when the student is enrolled.

2. Revenue Recognition:

The Institute recognizes significant items of income on the following basis:

(a) Tuition and other Fees

Revenue in respect of Postal and Oral Tuition Fees are recognized as and when the student is enrolled and receivable from Head Office.

(b) Sale of Publication

Revenue in respect of sale of publications is recognized when such publications are transferred to a user for a price.

(c) Others

Revenue from Programmed Fee is recognized as and when such activity is undertaken.

(d) Interest

Interest income for the year due on Fixed Deposits/Flexi Accounts/Saving Account with Banks is recognized on accrual basis taking into account the amount accrued and at applicable rate.

(e) Income from Investments is recognized as and when the right to receive the payment is established.

3. Expenditure:

The expenditure is recognized on accrual basis including expenses related to postal and oral coaching.

4. Property, Plant and Equipment:

Property, plant and equipment are stated at cost less accumulated depreciation and net of impairment, if any. Cost comprises the purchase price and any other cost, attributable to bringing the asset to its working condition for its intended use.

Intangible Assets

Intangible Assets being computer software are carried at cost less accumulated amortization and net of impairment, if any.



Capital Work in Progress

Expenditure incurred on construction of assets which is not ready for their intended use is carried at cost less impairment, if any, under Capital Work in Progress.

5. Depreciation/Amortization:

- (a) Depreciation on Fixed Assets is provided on written down value method as per guideline provided by Head Office.
- (b) Book Value of Leasehold land including premium paid thereon are amortized over the Lease period. The ground rent, if any, are recognized as expense in the year for which such charges are due or payable.

(c) Rate of Depreciation as provided by Head Office

Present Rate of Depreciation on W.D.V. Method:

1.	Building	-	10% p.a.

6. Investments:

Long term investments are stated at cost. However, when there is a decline other than temporary, in the value of long term investments, carrying amount is reduced to recognize the decline.

7. Inventories:

Publication stock, Study Materials and Paper Stock including Prospectus stock etc. are valued at Cost or Net Realizable Value, which is lower.

8. Accounting for Provisions, Contingent Liabilities and Contingent Assets:

- (i) A provision is recognized:
 - a) when there is present obligation as a result of past event;
 - it is probable that an outflow of resources embodying economic benefit will be required to settle the obligation and
 - c) A reliable estimate can be made of the amount of obligation.
- (ii) No provision is recognized for:
 - (a) Any possible obligation that arises from past events and the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Chapter.
 - (b) any present obligation that arises from past events but is not recognized because it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation or a reliable estimate of the amount of obligation cannot be made. Such obligations are disclosed as



Contingent Liabilities. These are assessed at regular intervals and only that part of the obligation for which an outflow of resources embodying economic benefits is probable, is provided for except in extremely rare circumstances where no reliable estimate can be made.

9. Employee Benefits:

(i) Short term benefit:

The short term employee benefit is recognized as expense when claimed during the period. Unclaimed amount is provided for.

(ii) Post employment benefit such as P.F, Gratuity, Leave Encashment etc. are provided as applicable to Head Quarter, respective Regional Councils and Chapters.

10. Impairment of Assets:

At the Balance Sheet date impaired assets, if any, are identified and necessary provision as required is made.

11. Prior Period income/expenditure:

Prior period items which arise in the current period as a result of errors or omissions in the preparation of financial statements in one or more prior periods are separately disclosed.

Notes forming part of the Annual Accounts:

- 1) Closing Cash in hand as on 31st March, 2022 Rs. 5, 201/-, where as cheque in transit Rs.8,719/-
- 2) Balance Confirmation Certificates from Banks for all Bank Accounts maintained by Chapter as on 31st March 2022.
- 3) Bank Reconciliation Statement as on 31st March, 2022 for all Bank Accounts of the Chapter has been done and verified by the Auditor.
- 4) No other Bank Accounts are maintained by the Chapter other than those shown in the accounts.
- 5) Rate and Method of depreciation provided by the Chapter as per Accounting Policy of the Institute (Fixed Asset Schedule No-2).
- 6) Investment Details preferably in form of FDR with Scheduled Banks (Schedule No. 9)
- 7) Land & Building of the Chapter has been shown in the books of accounts as per previous practice.


