- 1. This contract shall be comprise of the Airconditiners. Same shall be delivered within 3 days from the date of receiving Supply Order along with Payment.
- 2. The Bidders shall quote their rates as "RATE PER UNIT" in both words and figures as per prescribed format of Financial Bid (Annexure-C) inclusive of GST and Installation Charge.
- The Bidders have to disclose the model number with brand name having 3 Star Non Inverter and Copper Condenser.
- 4. The amount quoted per unit basis in the financial bid will be the only criteria for evaluating the L-1 Supplier. If ICAI-Bhubaneswar Chapter feel necessary, may further negotiation with L-1 Bidder Only.
- 5. Negotiation shall be made for Bought Back or Scrape Sale of the following AC's by the ICAI Bhubaneswar Chapter only with L-1 Bidder only:
