**Corrigendum on Expression of Interest invited vide reference number ICAI-BBSR/EOI-Fixed Asset/30097 dated 07.10.2022**

With reference to expression of interest invited vide number ICAI-BBSR/EOI-Fixed Asset/30097 dated 07.10.2022, following amendments has been done in SI No. A & D:

**A. Eligibility & Selection Criteria:**

- Cost Accountants firms (**Proprietary or Partnership**) should have registered on or before 01.10.2020
- One of the Partner in case of Partnership Firm or Proprietor in case of Proprietorship Firm should have a **Valid Membership of ICAI-Bhubaneswar Chapter** on the date of application.
- Applicant or any of the Partners (s) are not taking monetary benefits directly or indirectly with the business of the Chapter, Regional Council and Institute.
- Applicant or any of the partner (s) are not involved as Council/Regional Council /MC Member during last four years
- Applicant or any of the partner (s) relatives are not associated as Employee of the Chapter/Institute/Regional Offices
- Applicant or any of the partner (s) are not associated as a regular Faculty /Guest Faculty of the Chapter/Regional Council Office for imparting Oral Coaching Classes and taking fees for the same
- Firms having experience in executing for preparation/updation of Fixed Asset Work in any organization (s) shall be given preference during selection for appointment of Auditors (Copy of the proof required to be submitted along with expression of Interest )
- The Managing Committee of ICAI-Bhubaneswar Chapter is the final authority to appoint the Auditors for the said assignments after due interaction with the applicants.

**D. Mode and Last Date of receiving application :**

- Application shall be received at Chapter Office in hard copy with sealed envelope
- Soft copy of the application shall not be considered
- Last date of receiving of application at CMA Bhawan, Nayapalli, Nilakantha Nagar is **17.10.2022 by 7.00 PM.**
